- 5) Affordable Housing



STRATEGIC PLAN UPDATE

Strategic Plan Update ... Real People, Real Impact!

GOAL: To advocate for, coordinate and expand access to services that promote self-sufficiency among low-income people and vulnerable populations.

IMPACT:

◄ Transportation

MFCS provided a total of 17,671 trips for 1,094 unduplicated consumers in FY 2015-16, including 1,238 trips for 146 consumers as a result of the new Mobility Enhancement Grant that enabled us to expand our hours of service.

◄ Job Training/Employment

MFCS assisted 166 low-income individuals in finding employment and 45 low-income individuals in securing a living wage job. In addition, 36 individuals completed a GED and 194 individuals completed a AA/BA degree or Technical Training program.

■ Utility Assistance

MFCS provided 5,358 low-income households with energy assistance to restore or prevent their electricity from being disconnected.

◄ Healthcare Services

MFCS assisted **1,269** low-income consumers with access to healthcare services, including prescriptions, medical treatment, dental care and eyeglasses.

◄ Housing

MFCS assisted 437 low-income households with rent/mortgage assistance to prevent eviction/foreclosure or obtain safe, affordable housing.

◄ Self-Sufficiency

- A total of 41 or 78% of participants obtained full or part-time employment.
- A total of **38 or 73**% of participants achieved self-sufficiency during the 2015-16 fiscal year.

Karen was introduced to Mid Florida Community Services' (MFCS) Family Self-Sufficiency Program (FSSP) while receiving help with her electric bill through Low-Income Home Energy Assistance Program (LIHEAP). MFCS helped her with books, shoes, scrubs, medical supplies and gas cards to get to and from school. She completed the Medical Assistant Specialist Program at Pasco-Hernando State College. With her training, she was able to secure a livable wage job with benefits at a local health care facility providing clinical and administrative support to physicians.

Wearing a smile she says proudly, "I'm off food stamps and I can pay my own electric bill. My air conditioner broke and I was able to fix it. Before, I was borrowing money from others and now I'm self-sufficient." Karen worked hard in the FSSP and often sacrificed wants for needs, "I was without cable and internet service for two years, but now I can afford it." Her advice to others interested in FSSP is, "Take the help. MFCS is caring, giving and they will check on you to make sure you're okay. I wouldn't have been able to accomplish what I did without their help."



"I received assistance from Mid Florida Community Services' Family Self-Sufficiency Program to complete Withlacoochee Technical College's Electrical Program. They helped me with tuition, travel and the cost of tools. I couldn't have completed the program without their help. The Family Self-Sufficiency Program has completely changed my outlook on my path to success. I'm able to now state that I have completed a trade! Juvenal, Malloy Head Start

Juvenal began the 2015/2016 school year with severe dental decay, 13 teeth out of 20 had severe issues and needed to be restored. He was also facing the possibility of losing his 4 front teeth. Julyette Santiago and Suzette Otero, the Family Advocates for Malloy, worked very hard on Juvenal's case, as he had no insurance. Julyette and Suzette helped Juvenal's family complete all of the proper paperwork for Medicaid. Once the child was approved for Medicaid, they worked closely with the Oral Health Services Coordinator, Beatriz Treland, to schedule Juvenal's pre-operative exam for oral surgery. The surgeon, Dr. Elmore, completed the preoperative exam, identified his needs and felt confident that she could handle them all. Surgery day quickly approached and Dr. Elmore was able to restore all 13 teeth. Working together with the family as a team, our Family Advocates and Health Team were able to provide a successful outcome for Juvenal. Juvenal is happy and thriving in the classroom with a great smile!

LAKE COUNTY SENIOR SERVICES CASE MANAGEMENT

Ms. Christine is a 64 year old female who was referred to MFCS in early January as an Adult Protective Services client due to self-

neglect.

During the initial assessment, we found that Ms. Christine was unable to complete most of her Activities of Daily Living due to declining health and mobility conditions. She also needed immediate assistance cleaning her home, and personal care because she was unable to take baths without assistance. Mid Florida Community Services immediately put Homemaking and Personal Care services in place provided by Families Come First. Initially, Ms. Christine was very hesitant about having MFCS staff in her home.

By the 30 day visit, the case manager noticed a change in both her appearance and attitude. Ms. Christine was very grateful and appreciative of the services being provided. Over the course of several weeks, Ms. Christine's self-esteem increased and she was able to live independently with dignity, avoiding placement in a nursing home.

SENIOR SERVICES

HOME CARE FOR THE ELDERLY (HCE)

This program provides a monthly stipend to Seniors to utilize at their discretion for purchases to address their daily needs.





CONGREGATE MEAL SITES

These sites offer free nutritious meals to Seniors as well as an opportunity for social interaction.

MEALS ON WHEELS

A home meal delivery service that delivers quality food daily to Seniors who otherwise may not have access to healthy, nutritious meals.



RESPITE CARE

Provides a break to allow Caregivers of Seniors to conduct personal business (i.e. shopping, hair care, socialization, etc.)



PETS ON WHEELS

This is a home delivery service that delivers dog/cat food to Seniors in effort to prevent them from sharing human food with their pets due to financial struggles.

ALZHEIMER'S DISEASE INITIATIVE (ADI)

This program serves clients of all ages and provides respite care to caregivers of those struggling with the disease.

COMMUNITY CARE FOR THE ELDERLY (CCE)

This is a program where Seniors are assigned to a Case Manager who routinely assesses and address their personal health, nutrition and homecare needs.

RSVP 'Pets on Wheels' Volunteer Story

Edith "Edie" Wilson is the driving force behind the "Pets on Wheels" program, which is a small grant administered by Meals on Wheels of America to provide dog/cat food to seniors throughout Hernando County. In 2015, Edie logged 1,397 hours and packaged 3,662 pounds of dog/cat food, feeding an average of 107 pets per month.

Ongoing research suggests that pets not only provide companionship, but also have a positive impact on overall senior health to include an emotional/psychological component. Without Edie's selfless dedication, these seniors may not be able to keep their beloved pets or they may choose to go hungry themselves and feed their pets the food delivered for them by our Mealson-Wheels program.



As a testament to Edie's devotion to the program, the recent loss of her husband did not slow her down. Instead, she honored the memory of her husband by continuing to compassionately serve others.

CHILDREN'S ADVOCACY CENTER

The Children's Advocacy Center of Hernando County is dedicated to reducing trauma to victims of child abuse and their families through intervention, prevention and education.

The CAC provides trauma-focused therapy and other counseling services to child victims and their non-offending family members to begin the healing process.

Tickets sold out weeks ahead of the big event, with more than 400 people in attendance! This year, over \$35,000 was raised, which is a substantial increase from last year. It was a fun, exciting night with 14 designer purses given away to the winner of each round of bingo. The lucky winner of the bonus round won a Louis Vuitton purse valued at \$1,820.00!

S. is a 17 year old girl who came to therapy experiencing symptoms of depression, anxiety, and impulsive behavior. She had been making bad decisions, (i.e., sneaking out of the house, inappropriate social media behavior), and was feeling more and more detached from her family. S. had been adopted at the age of 10, following years of substance misuse, transience, and exposure to sexually inappropriate behavior by her biological mother. She was removed and placed in foster care with a non-relative, a surrogate grandmother, then had to be removed from her care. During these traumas, S. herself was victimized once at the age of 5, and again twice more in the next two years. When S. came to services, she was reluctant, stating that she was scared to facing things, and experienced depression, nightmares, fear, and suicidal thoughts. S. was able to build a strong rapport with her therapist, and began to talk about her experiences in a safe, non-judgmental, relaxed way. In time she began sleeping better, coping better, and making better choices. S. participated in a therapy known as TIR, Traumatic Incident Reduction, with her therapist, Which led to a change in her perspective and outlook that made it easier for her to be successful. S. graduated from high school in 2016 and is now enrolled in college.



"Dear Ms. Michele,

You have been such an amazing light in my life. Talking to you and seeing things from a different perspective has really changed the way I look at things and go about my daily life in a good way. Never would I have imagined that the deepest things that bothered me the most would one day never bother me again and that would not be possible if it was not for you. It is crazy to think how the first session I wanted nothing to do with another round of counseling and now here I am not wanting to leave. You have left such an impact on my life that will do nothing but benefit me from here on out. I can not thank you enough and if I could I would. Thank you again for helping me become a better person." - S.




